Brief on the conference

The conference on "Ageing and Senior Care -A Collective National Responsibility" is being organized to increase the awareness about the current status and the issues faced by Senior Citizens in the Country and also to deliberate further course of action involving Government (States / Center), Corporate Houses, Senior Citizen Associations /NGOs and the Society at large

- The Senior Citizens have been guaranteed protection under the constitution (Art 4.2) and later was reinforced by the "National Policy for Older Persons" in the year 1999.
- Govt. of India has passed 'Maintenance and Welfare of Parents & Senior Citizens Act 2007". The implementation of the Act in most of the States is not at all satisfactory. The awareness among the implementing authorities is very poor. We have to spread awareness and sensitize the Govt. in States as well as at Center level for effective implementation of the Act.
- As per Companies Act 2013, the companies have to spend 2% of their average profit under Corporate Social Responsibility. Though welfare of Senior Citizens is amply covered under Schedule VII of the act but allocation of funds for Senior Citizens welfare is very poor. This is mostly because of poor awareness and insensitivity for Senior Citizens in the Corporate Houses and as well the ignorance on the part of Senior Citizen bodies in the Country.

Agenda

- The conference will help in dissipating the latest status and developments in the implementation of the various Govt. policies. Through the presentations from learned speakers/specialists and interaction on the subject, we expect that some ideas will emerge for initiating the actions at our end and at the level of Govt. and NGO.
- Feasibility of possible initiatives which can be taken by the Society without depending on Govt. Machinery.

Actions Suggested

- Each State should have a separate Ministry and Commission to look into the welfare of Senior Citizens.
- Advisory be issued by GOI, HRD Ministry that each Nursing Schools/Colleges should have a separate department for Training of Care Givers for Senior Citizens.
- Urban Development Ministry may make it mandatory for all builders/developers to provide acommunity hall suitable for about 100 persons along with necessary wash-room facility in each complex for use as Day-Center by senior citizens to mitigate the problem of loneliness.
