NIRDHAN JAN SEWA CAMP ORGANISED IN SANT KABIR NAGAR, LUCKNOW ON 10th JANUARY, 2021

BHAVANA organized its third "Nirdhan Jan Sewa Camp" of this winter on Sunday, 10th January, 2021 in Sant Kabir Nagar locality, Faizullaganj-2, Ghaila Road, situated on the periphery of Lucknow City. 50 new all wool blankets were distributed to pre-identified very poor families, headed by senior citizens residing in this locality. One blanket was given to each of the 50 families selected.

Persons assembled in the camp were also given awareness lessons with practical demonstration on the following issues which are very relevant for their wellness and wellbeing:

- 1. Simple tips for maintaining personal hygiene and health without medication.
- 2. Keeping the environment clean and healthy within and around one's own dwelling.
- 3. Tips about precautions that are to be taken by the village folks in the current "Corona Pandemic".
- 4. About various schemes of Central & State Governments already available for the welfare of poorest of the poor.

BHAVANA's Nirdhan-jan Sewa Mission is totally funded by its own members and donors. BHAVANA's Mission has nothing to do with the blankets distribution programme of Government of U.P. or of any other organization.

Every year around ten such camps are organized in urban as well as rural areas of Lucknow and adjoining districts wherein around 1000 new all wool blankets are distributed to poorest of the poor families headed by senior citizens. In addition, around 2000 used but re-usable garments, bed-linen, utensils etc. are also distributed to the needy persons attending the camp. BHAVANA has been organizing such camps in every winter for the last 15 years without fail. This camp was third in the series of such camps this winter.

Summary of previous two camps held during this winter:

<u>27th December</u>, <u>2020</u>: Village Thakurpur, situated around 60 km. away from Lucknow, in Barabanki district. 100 new all wool blankets were distributed to pre-identified very poor families, headed by senior citizens residing in this village and adjoining village Shyamnagar and their hamlets.

<u>04th January</u>, <u>2021</u>: Block & Tehsil Hasanganj, situated around 40 km. away from Lucknow, in Unnao district. 100 new all wool blankets were distributed to pre-identified very poor families, headed by senior citizens residing in villages Amoiya, Jagdishpur, Kurauli and their hamlets.

BHAVANA's team is grateful for the help provided by the local young volunteers headed by Sri Pramil Dwivedi in organizing the Sant Kabir Nagar camp and identification of prospective beneficiaries.

Clean used but re-usable garments (but strictly not undergarments), bed-linen, utensils etc. are also welcome.
